With the Flight Centre case, Australia's highest court upset bedrock precepts of agency and competition law. Principal and agent are traditionally viewed as one before the law, such that they cannot compete with each other. Rebuffing this, and looking beyond contract, the majority muddied the waters for industry and its antitrust advisers, compelling airlines to ask "when is my agent my competitor as well?"
