## CBP Document Validation Overview

The CBP Document Validation Program is the next generation in traveler data transmission providing ***Real-Time Document Matching*** and ***Interactive Response Messaging*** to seamlessly ensure that legitimate travelers are able to enter the country while maintaining a positive traveler experience.

- CBP Document Validation leverages the Advance Passenger Information System (APIS), which is CBP’s system for providing an efficient means for air carriers to communicate traveler manifest data.

## CBP Document Validation Capabilities



### Real-Time Document Matching

Using CBP records on file, real-time matching generates automated boarding recommendation in seconds.

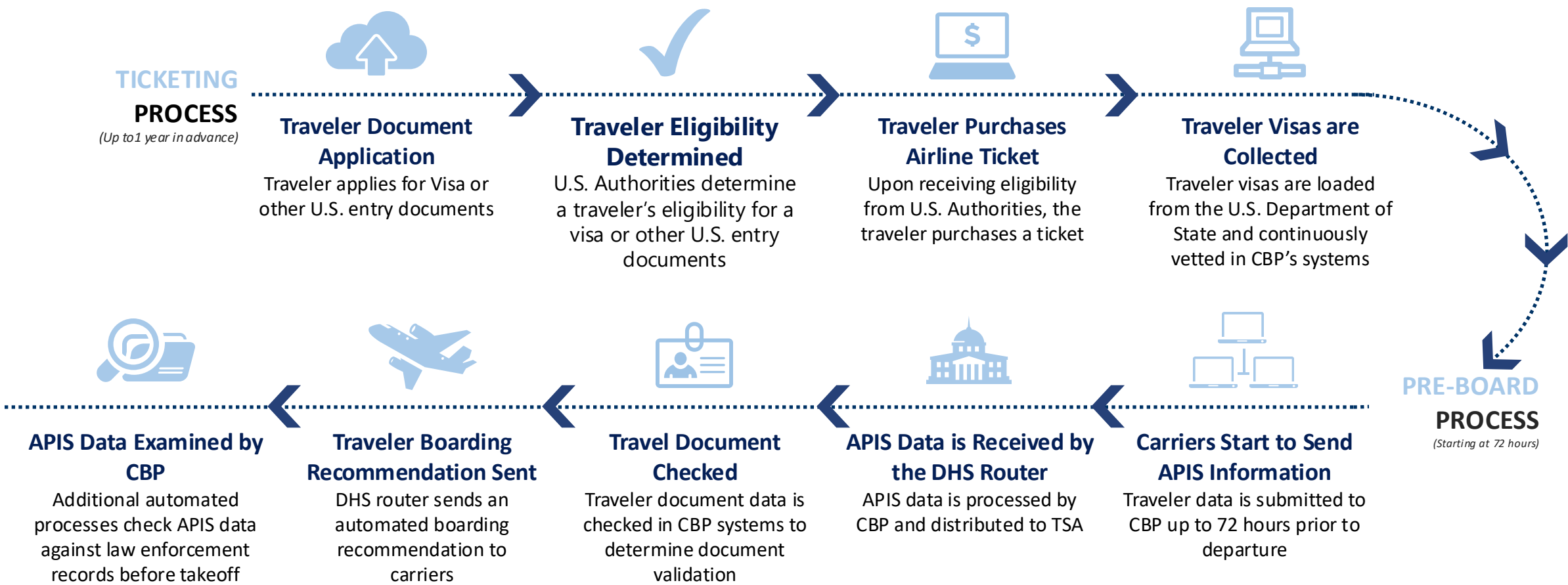


### Interactive Response Messaging

Upon determining a boarding recommendation for a traveler, CBP sends an instantaneous response to the carrier.

CBP Document Validation Program Benefits



1. Streamlined Operations

Document Validation streamlines operations by offering reduced manual processing, decreased airport wait times, and improved APC kiosk interfacing/biometric matching.



2. Heightened Security

Document Validation reduces exposure to invalid or erroneous documents, improves APIS data quality, and reduces system errors with system generated responses.



3. Reduced Penalties

Document Validation reduces penalties associated with invalid traveler information and limits the number of non-cleared travelers returned to their place of origin.



4. Enhanced Traveler Experience

Document Validation enables expedited travel by reducing the likelihood of data errors resulting in false matches, reducing time spent with CBP upon arrival.

Out of every 100,000 Visa Waiver Program (VWP) travelers require manual processing by the airline

## CBP Document Validation Program Notice of Proposed Rulemaking

In an effort to support border operations over the next decade, on February 2, 2023, CBP published a comprehensive update to APIS regulations.

As with previous APIS implementations, the Regulation proposes to update 19CFR 122.49(a) and 122.75(a) for arriving and departing commercial airline passengers in an effort to transition the Document Validation Program from a voluntary program to a mandatory program.

The NPRM process allows for public comment on the proposed new requirements.

### The NPRM covers:

**Document Validation** – requirements for the program

**Dual Nationals** - optional transmission of additional documents for dual/multi nationals to more efficiently clear travelers

**Second occurrence of a name** – optional submission of a second name, such as a married name or name slightly different than the passport on another travel document

**Additional data elements** – including e-mail, 2 phone numbers and street address to meet both CBP and CDC needs

**Tail Number** – if available, for future developments of the electronic GenDec
