# **IOSA FLT Auditor**

## **About The Role**

As an auditor under the IOSA program you will be assigned by the IOSA team to conduct audits around the globe. You will play a key role in determining operator's conformity against the IOSA standards and recommended practices, and your insights will be key to help operators to identify potential areas of improvement. Furthermore, by applying a risk-based approach, you will be contributing to assess an operator's maturity on safety related practices.

About The Role: The IATA Operational Safety Audit (IOSA) program is recruiting freelance flight operations (FLT) auditors. The IOSA program compensates auditors as independent contractors for IATA. Please note that this recruitment includes a mandatory initial training with IATA, and if successful, an onsite assessment that must be successfully completed at the applicant's expense. Candidate auditors will be selected only if all the selection / qualification stages are successful. I the candidate will be selected.

Participation in the IOSA program requires an auditor to be available for a minimum of three (3) audits per calendar year. Auditors must be willing and capable of dedicating a minimum of 20-25 days per year to complete audits. Furthermore, all IOSA auditors are required to attend any training sessions assigned by the IOSA program (this includes remote trainings and one mandatory in person training session per year).

## Experience

#### Required

- More than five years of experience operating as a Pilot for an operator utilizing a transport category aircraft with a MTOW of more than 5700kg.
- Over 2 years of experience conducting aviation audits or verifiable proof of having completed more than 10 audits in the role of Auditor or Lead auditor in the aviation industry.
- More than two years of experience in one of the following:
  - Flight operations management for an operator utilizing a transport category aircraft;
  - As a pilot flight crew instructor or evaluator (aircraft and/or simulator) on transport category aircraft;
  - As an airline flight operations inspector on transport category aircraft of NAA or;
  - As a flight operational quality or safety auditor for an operator utilizing transport category aircraft.

#### Preferred:

- More than five years of experience as a trainer or evaluator of dynamic simulator.
- More than five years of experience operating as a Pilot in Command (PIC) for an operator utilizing a transport category aircraft with a MTOW of more than 5700kg.
- Experience as a SMS manager or a related operational role.



## Education

Required education is completion of secondary school

## Certification

### Required:

- Hold a (non-frozen) Air Transport Pilot License (ATPL) on a transport category aircraft with a MTOW of 5700 kg for minimum of five years within ten years immediately preceding the application.
- Hold a SMS training certificate from airline related training provider.
- · Hold an Auditor training certificate.

## **Skills**

- In depth knowledge of quality and safety audit principles, procedures and techniques.
- Advanced knowledge and understanding of IOSA guidance material, programme and safety related requirements.

- Knowledge of audit software.
- Experience working with IOSA (e.g. involved in the operator's internal assessment of the IOSA ISARPs and/ or IOSA audit preparation).
