Chicago on Safety and Airworthiness – A Need to Flex?

Issues of safety, airworthiness and certification, as well as mutual recognition, pose questions at the intersections of public and private law. How have the principles at the heart of the Chicago Convention flexed since 1944 and, if they haven't, do they need to for effectiveness? Track 1 – Taxation Flashpoints in International Air Transport

Chicago left some hard tax questions unresolved, touching only indirect taxation. The industry's international reach makes for the thorniest of double taxation problems save for a degree of alignment between governments in other places on income, jet fuel, sales taxes (ie VAT/GST) and import duties. Pressure now abounds however with developments on the Article 8 principle, the OECD framework on BEPS and a new UN-sponsored taxation convention. Our panel will appraise the current international legal situation on taxes, identify the near-term flashpoints for airline businesses and scope areas for renewed harmonisation.
