Ladies and Gentlemen

The aviation sector in Africa has come a long way and faced numerous challenges within the continent and at international level. It has endured difficult domestic economic conditions and limited markets. Even the current global financial downturn

has not stopped its progress. It still continues to deliver benefits to the socioeconomic development of the continent.

Given the poor state of many African economies, one would have expected most African carriers to disappear from the world scene when even some major international airlines with once famous names are no more. But thanks to the commitment and ingenuity of some dedicated professionals, we see a number of African airlines maintaining their market share and some even flourishing. These remarkable actors have never fallen short of dynamic strategies to cope with emerging challenges.

The African Union Commission is pursuing the agenda of creating a single strong African aviation market and, ultimately, a single safe and efficient African sky emerging soon as a result of implementing the Yamoussoukro Decision and the African Civil Aviation Policy which are strategic frameworks for the continent.

In that quest, the AU Commission is working closely with both internal and external partners. African organisations like the Regional Economic Communities, AFCAC, AFRAA and NPCA are considered as members of the AU family who have a collective ownership of this agenda. ICAO, IATA and other international institutions are expected to provide the requisite technical support to enable Africa's air transport industry plays its expected role in the global economy.

As I mentioned at the beginning, the Africa Union is celebrating this year its 50th anniversary since the founding of its predecessor, the Organisation of African Unity. In that regard, I wish to invite you to join the African Union Commission to promote and facilitate the commemoration which was inaugurated on 8th April 2013 and will

cover the period till May 2014. To that end, the African aviation industry is expected to be one of the major faces of the event especially by placing colourful displays in international airports and on board of all flights.

Let me also inform you that the Third Session of the Conference of African Ministers of Transport is scheduled to hold in November 2013 in Malabo, Equatorial Guinea. In air transport, an assessment will be done with a view to defining the way forward in the context of current global developments. Proceedings of this event would hopefully contribute significantly to the agenda of the planned Ministerial conference.

I, therefore, wish you successful celebration of the IATA Africa Aviation Day and very fruitful deliberations in assessing the challenges and opportunities for aviation in Africa.
