After investigation it was found that the member might have copied the text from some source to field 'Correspondence Text'. When this text is pasted, some HTML tags also got pasted. In IE 9, the system was allowing saving of such HTML tags but while sending the Correspondence because of these tags it was throwing an unexpected error</p> <p>Corrective Action: The code has been modified to restrict such HTML tags from getting pasted inside the field 'Correspondence Text'</p>

1.11.5	8656047	Minor	SIS-PROD: ERROR	<p>Area: ISWEB</p> <p>Issue: There was an issue in MISC Invoice captured via IS-WEB in Mozilla Browser. The system allowed the user to enter 81 characters for the field Additional Detail Description in Invoice Header screen when creating Invoice using Mozilla browser. The maximum size of this field is 80 characters only. The validation to enforce the maximum size was missing.</p> <p>On investigation, we found that this issue also exists for Remarks field under Payment Terms at Invoice Header level.</p> <p>Corrective Action: The issues have been fixed and validations with the appropriate error message have been implemented</p>

1.11.5	8749245	Major	Error uploading invoices in the database	<p>Area: ISWEB</p> <p>Issue: Files were failed in production with "Error code "BGEN_00007: Error uploading invoices in the database, Please contact SIS Operations."</p> <p>While investigating this issue, it was found that this issue has occurred due to the maximum number of sessions/processes in the database have reached the configured threshold. Beyond the configured limit, the database was not accepting the new connection.</p> <p>Corrective Action: As a preventive action DBA team has increased this parameter value in the database from 1000 to 1500.</p>
