This document intents to provide understanding of IATA IS-XML standard usage benefits when used in conjunction with SIS e-Invoicing platform (Simplified Invoicing and Settlement)



#### Introduction

Integrated Settlement XML IS-XML is an IATA EDI standard that allow exchange of billing and reconciliation information

This standard has been specifically designed to be used in conjunction with the IATA e-Invoicing platform SIS (Simplified Invoicing and Settlement) that operated as a data hub.

The standard is asymmetric, billing information sent by the supplier to SIS differs slightly from the information sent from SIS to the airline, due to data enrichment, tax and VAT treatment and other flags that trigger data modification or for legal process to happen.
