



Travel and local restrictions during COVID-19

We are closely monitoring travel and local restrictions. As the situation evolves this information will be regularly updated and we will make sure we inform all delegates in good time if we are unable to hold this event in person.

In a recent IATA survey, 75% of delegates¹ have their business' support and intend to travel to attend the Slot Conference in person if travel restrictions allow. Depending on where you are travelling from and your individual circumstances it will determine how you can attend this event. In preparation for those of you intending to travel to this conference, we have provided links to the latest information below. This information is provided as general guidance only. Whilst we have tried to ensure the information is accurate and complete, IATA cannot be held responsible for any inaccuracy or omission. We strongly recommend you make your own inquiries.

Attending a conference in Italy

As of August 6, 2021, Italian Authorities have established the mandatory requirement of a "Green Pass" or EU Digital Covid Certificate or equivalent certificate recognized by the Italian Authorities, for any person aged 12 and above, in Italy, wishing to attend exhibitions, trade fairs, conferences and congresses. A Green Pass must show proof of either having received one dose of vaccine²; or of a negative result of a molecular or antigenic test carried out in the previous 48 hours; or of having recovered from Covid-19 in the previous 6 months.

Getting there

Before planning your travel to and from Italy, we recommend you use IATA's Travel Centre [online check and Timatic interactive world map](#), which provides users with the latest information and requirements for individual travel. It is your responsibility to ensure you meet the requirements for entry to Italy.

This simple, free, online check determines the necessary documents that travelers are required to provide to travel (passports, visas, [EU Digital Passenger Locator Form \(dPLF\)](#), [link to form](#), health

documents) alongside quarantine, vaccination and COVID-19 testing requirements at their destination and on their return.

Travel and Health Insurance

It is advisable to ensure adequate travel and health insurance when attending an event to provide you with the necessary cover.

Local restrictions

The latest information on the COVID-19 situation in Italy, as updated by the Italian Ministry of Health, can be [found here](#). Rome is located in the Lazio peninsula of Italy and is currently classified as a white area. Which means:

- Total freedom of movement, day and night
- All activities are open (subject to Green Pass entry requirements), including arcades, casinos, betting agencies and bingo halls. All amusement parks, community and recreation centers are open. Nightclubs are open but dancing is not allowed, and it is only possible to eat, drink and listen to music
- It is still compulsory to always wear a mask indoors, and outdoors only when social distancing of at least 1 meter is not possible

Italy's Green Pass

The [Green Pass](#) or COVID-19 green certification confirms if people have been vaccinated, tested negative or recovered from COVID-19. This digital or paper certificate is required for certain activities including access to conferences and congresses. Specifically, it certifies:

- administration of at least the first vaccination dose³ [from a list of recognized vaccines](#) (valid for nine months);
- recovery from COVID infection (valid for six months);
- rapid molecular or antigen test with negative result (valid for 48 hours).

The Green Pass or EU Digital COVID Certificate, or an equivalent certificate issued by the health authorities of Canada, Japan, Israel, the United Kingdom and the United States, is mandatory in order to access the following activities within Italy:

- indoor restaurant/bar services
- sporting events and competitions
- museums, theaters and other places of culture

³ Please note, to enter Italy passengers are required to have completed all doses related to their vaccine in the required timeframe, likewise to enter the airport on departure the same is required.

- swimming pools, gyms and wellness centers, limited to indoor activities
- festivals and fairs, conferences and congresses
- spas, theme and amusement parks
- most forms of public transport

For a complete list of activities and services that can only be accessed with the Green Pass please review this [link](#). The measures indicated in the above section are valid until 25 October 2021. Those excluded by age from the vaccination campaign and those with suitable medical certification are exempt.

Rapid COVID-19 test and the Green pass. For those that are not vaccinated (or vaccinated from a list of recognized vaccines (valid for nine months) they can obtain a green pass, valid for 48 hours by testing negative to a rapid COVID-19 test readily available from local pharmacies and test centers. The test provider will print your test results and will email you a unique code. You will then need to access the Government website (in Italian) and enter your details. Select the option 'Utente senza tessera sanitaria' ('User without a health card'). You will be prompted to enter the type and number of the ID you showed when you got your test, as well as the code on your test certificate. Click 'Ripristina certificazione' ('Get certificate') to download your digital test result.
