





WORC2024 Key Takeaways

- 1. Lack of standardisation and consistency, along with an inconsistent approach to managing overflight risks
- 2. Over-reliance on state-sourced intelligence
- 3. Inefficient manual processes hindering effective risk management
- 4. Reactive, undocumented decision-making increases legal vulnerability





The Need for Standardisation

Unified Definitions and Risk Levels

ICAO and IATA must agree on standardised terminology and methodology.

Mandatory Civil-Military Coordination Protocols

• Especially in regions of known military tension or active operations.

Leverage OSINT and Technology


Predictive Intelligence and Dynamic Risk Monitoring

Airspace Governance Reform

• Independent international oversight when states fail to proactively close airspace during periods of risk.

Mitigation Strategies for Underwriters

Push for Policy Clauses that Account for Political and Conflict Risk

• Tailored endorsements covering sovereign responsibility, closure obligations, and liability in conflict zones.

Encourage Clients to Use Independent Risk Intelligence Providers

• Predictive Intelligence (Forecasting) and Dynamic Risk Monitoring.

Demand Evidence of Pre-Flight Risk Assessment

• Technology enables systematic risk assessment of every single flight operation

Collaborate with Aviation Regulators

Participate in the development of unified standards and advocate for enforceable international guidelines.
