#### **SIS Users**





- +14,000 users configured for Active SIS Members (+35% / Aug 2017)
- → + 5,600 users truly active on IS-WEB (+47% / Aug 2017)



#### **SIS File Processing Performance**

- ▼ File processing performance remains at high levels with 99.59% files processed within less than 10 min over the last 12 months
  - One exception occurred in May P1 2018 in relation to a security fix put via Major Rel. 1.12 which impacted file validation process.
    - >> Correction was made via Hot Fix day after as to gain back usual performance
- Reminder: consider to send multiple files when
  - High number of transactions
  - High ratio of RMs vs Prime Coupons






### SIS File Processing Performance (Sep 17-Aug 18)

#### **SIS Solution Security Update**

- Why this is important?
  - ✓ SIS is part of critical applications for our airline industry
  - Access to SIS and SIS data should remain secure



### **SIS Solution Security Update (2)**

- Several security controls are performed systematically on SIS Solution under IATA Security team review/control
  - Periodical vulnerability scanning helping proactive actions
  - Application code security and Penetration Tests performed <u>for every Major Release</u> via a company selected by SIS vendor
  - External Penetration Tests performed yearly via a company selected by IATA Security (rotation of company every year)



#### **SIS Solution Security Update (3)**

- ➢ Findings reported, if any, are prioritized and deployed at the earliest to SIS application via our Maintenance Releases schedule or via a Hot Fix if required
- ▼ To come: Reinforcement of Password policy to higher standards
  ( details to follow )



### **SIS Solution Security Update (4)**

- ✓ SIS application itself is <u>secure</u> but ... YOU need to
  - 1. Keep the operating system of your computer up to date
  - 2. Ensure that an antivirus product protects your computer
  - 3. Access IS-WEB using the most recent browsers







#### Access IS-WEB via recent web browsers: Why?

- Only recent web browser versions are getting patched with latest security fixes
  - Don't take a chance to be exposed
- → SIS is leveraging on recent browsers capabilities
  - e.g. in SIS Rel. 1.13, one change (CMP#743 Upload Multiple Input Files from Screen Upload File), so if you don't have a recent web browser version
    - ... this feature will simply not work!



#### IS-WEB Browsers Restrictions: what we did

- → At last SIS GM meeting (DUB), you were asked to update your browsers and IATA Security 2018 audits have reinforced the need for action
- ✓ Since Aug 17<sup>th</sup> 2018, <u>first IS-WEB</u> browsers restrictions are in place
  - → For Chrome v51, Firefox v51, IE v8, Edge v12, Safari v7 and any version below
  - ▼ with a Browser Error returned from IS-WEB if old versions conditions met
  - → + 400 active users requested via email to upgrade



#### **SIS Continues to Evolve**

- ✓ Since last GM 2017 (DUB), we improved SIS solution via these Major Rel.
  - ✓ SIS Rel. 1.11 Nov 2017
    - → 5 CMPs → Please refer to Release Communication <u>link</u> to review changes.
  - ✓ SIS Rel. 1.12 May 2018
    - **7 CMPs** >> Please refer to Release Communication link to review changes
- Next is SIS Rel. 1.13 in Nov 2018


#### Next SIS Major Release 1.13 - Nov 2018 (2)

- ✓ All SIS technical documentation and details on changes ahead are on IATA SIS Website Technical Documentation page
  - ✓ SIS Major Rel. 1.13 communication <u>link</u>
  - ✓ Updated ISPG version 3.9.0.1
- □ Deployment is planned on Nov 7th, 2018 after (Oct P4 closure) and before the start of Nov P1 2018 clearance



#### **SIS Infrastructure Update**

- As per our SOC2 requirement we executed a Site Switchover on Feb 24<sup>th</sup> 2018 between our two sites
  - ✓ SIS now operates from the Site 2 "backup" and will return to the Site 1 "primary" in Feb 2019





#### **SIS Infrastructure Update (2)**

- → Behind the scene: we keep SIS Infrastructure up to date!
  - ✓ Upgrade to a more recent storage version (SAN) was required and this was achieved in two steps in Jan / Feb 2018
  - Oracle database version upgrade in Jul /Aug 2018



### **What's Coming Ahead**

- ✓ CMP# 656: MISC Dispute Management to be deployed in Dec 2018 (date TBC).
- Implementation of new Password Policy prior end of year
- Additional IS-WEB Browsers restriction (2<sup>nd</sup> Phase) to keep only recent browsers versions (date TBC)
- ✓ SIS Site Switchover (return to Site 1 "primary") by end of Feb 2019
- ✓ SIS Major Release 1.14 by May 2019
