- Access all the essential features of BSPLink's digital platform simply.

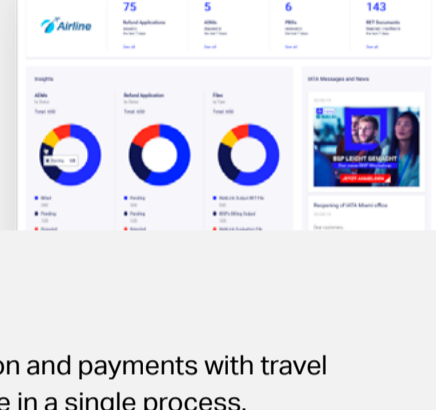

- Easily access all your records for up to 2 years.

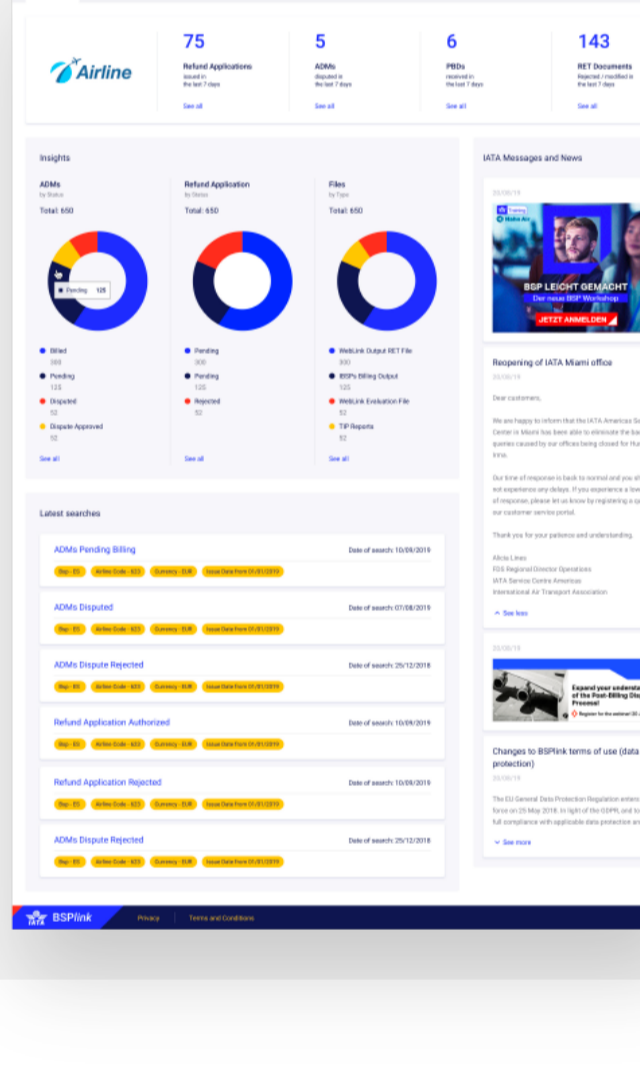
The new generation of BSPLink enables you to improve efficiency in your commercial and financial back-office processes:
