



# New Distribution Capability (NDC) Registry – Terms of Use

By accessing and using the NDC Registry, you agree to the following terms of use (Terms of Use):

## Scope of Designations

The NDC-Certified and NDC-Capable designations:

- Validate that the structure of an applicant's NDC messages accurately follows the relevant version of the applicable NDC schemas; and
- Are only valid as of the dates listed in the NDC Registry, for the version, level and messages listed.

The NDC@Scale designation:

- Validates the specific documentation provided by the applicant against a set of criteria that demonstrate the applicant has a minimum set of recognized capabilities to drive volumes of NDC transactions.

PLEASE NOTE: The NDC-Certified, NDC-Capable or NDC@Scale designations do not entail any kind of certification, validation or endorsement of (i) any aspect of the applicant, (ii) the quality or other aspects of its activities or products or XML API, (iii) any commercial products that may be derived from the usage of validated NDC messages or the XML API.
