



# Key Changes to 14<sup>th</sup> ULD Regulations (ULDR)

- ➤ To support standard ULD operations on the newly introduced Airbus A350 Freighter Main Deck, several updates have been made across the ULDR:
  - ✓ Section 2: Updated aircraft contour information
  - ✓ Section 4: Introduction of a new aircraft container contour code 'W', forming the new ULD Type Code 'AMW'

✓ Section 5: Maximum allowable contour details for code 'W', along with aircraft

compatibility information







## Key Changes to 14<sup>th</sup> ULD Regulations (ULDR)

- Recognizing that using incompatible pallets and nets violates safety requirements, we've enhanced the SS 50/5 Pallet and Net Compatibility information in Section 5 to improve clarity and usability.
- Section 6 will feature an update to OS 6/12 Aircraft Engine Carriage, aligning it with the ICHM Appendix L
- In support of IATA Cargo's sustainability initiatives, a new Appendix J will be introduced, offering guidance on conducting Life Cycle Assessments (LCA) for ULD.



#### Key Changes to 14<sup>th</sup> ULD Regulations (ULDR)

- Following the successful adoption of the Competency-Based Training & Assessment (CBTA) approach two years ago, a new matrix template focused on the ULD build-up function will replace the current Appendix G and being referred to in Section 1.6 under ULD Training Requirements.
- The Glossary section will be revised based on recommendations from the Definition Alignment Task Force (DATF), ensuring greater consistency and clarity across terminology.
