

What is Maintenance? - Lessor


Lessor arrangement to protect and control⁽¹⁾owner's ownership interest in the aircraft and its parts⁽²⁾technical actions carried out by an operator which would affect the current and future value⁽³⁾and could impact the ability of other operators to operate it⁽⁴⁾





What is Maintenance? - Airline

Operator's arrangement to execute ⁽¹⁾ physical work on an aircraft such as repair, overhaul, replacement and inspection ⁽²⁾ in accordance with the operators policies, procedures, practices and in compliance with aircraft registrar requirement ⁽³⁾ and the keeping of execution completion evidence ⁽⁴⁾
