# Membership

- IATA membership: some 350 airlines in 126 countries and territories.
- IATA members represent over 80% of total scheduled traffic (revenue tonne-kilometers, 2023)
- IATA members' total cargo (scheduled) 59 million tonnes in 2024, of which 41 million tonnes were international
- IATA members' total cargo tonne-kilometers (scheduled) 254 billion tonne-kilometers in 2024, of which 223 billion tonne-kilometers were international
- IATA members' total passengers 2024 (scheduled) 3.3 billion, of which 1.4 billion were international
- IATA members' total revenue passenger-kilometers 2024 (scheduled) 7.3 trillion passenger-kilometers, of which 4.7 trillion passenger-kilometers were international

### History

• In April 1945, a group of 57 airlines came together in Havana, Cuba, to create IATA.



• IATA was formally established in Montreal, Canada later that year in December by a Special Act of the Canadian Parliament.

# IATA Annual General Meeting & World Air Transport Summit

- Formalizes industry positions on aviation and public policy issues and provides a focus on emerging issues
- Attended by representatives from IATA member airlines, industry partners, international and regional associations, manufacturers, suppliers, and governments
- The first Annual General Meeting (AGM) was held in Montreal, Canada, in October 1945
- The 81<sup>st</sup> AGM took place in New Delhi, India, on 1-3 June 2025, hosted by IndiGo
- The 82<sup>nd</sup> AGM will take place in Rio de Janeiro, Brazil, in June 2026, hosted by LATAM Airlines Group

# **IATA Financial Services**

- In 2024, IATA Financial Settlement Systems (IFSS) processed some \$445.3 billion excluding refunds as follows:
  - o Billing and Settlement Plan (BSP) \$232.8 billion (net of \$19.1 billion in refunds)
  - Cargo Account Settlement Systems (CASS) \$46.6 billion
  - o IATA Clearing House (ICH) \$63.75 billion
  - IATA Currency Clearance Service (ICCS) \$41.0 billion
  - Simplified Invoicing and Settlement (SIS) \$83 billion
  - Enhancement & Financing \$4.2 billion
